## **Instruction Manual**

# **Inserting batteries**

Insert the two AAA batteries with + and - sign as indicated inside the battery compartment. The clock will start running from 12:00 AM January 1, 1996.

## To Set Calendar

Slide the **SET SWITCH** to **CALENDAR**. Press **MONTH**, **DATE**, or **YEAR** buttons to set the month, date, and year of the calendar. Then slide the **SET SWITCH** to **LOCK** to run the clock and calendar in normal mode.

## **To Set Time**

Slide the **SET SWITCH** to **CLOCK**. Press the **HR** or **MIN** button to set the current time. Then slide the **SET SWITCH** to **LOCK** to run the clock and calendar in normal mode.

#### 12 HR AM/PM or 24 HR International Time Format

Press the 12/24 button to choose the desired time format.

# °C or °F Temperature Format

Press the °C/°F button to choose the desired temperature format.

## SYNCHRONIZING WITH WWV

To synchronize the time with WWV, follow the instructions for "To Set Time". Set the time to one minute before the designated time. Then press the **MIN** button at the signal. The seconds will automatically reset to zero each time the minutes are changed. Now your clock is synchronized with WWV.
